A member of the public congratulated Cllr Young for her efforts in getting new gates installed at the Milley Bridge entrance to the village. It was noted that the speed limit remains at 40mph but a campaign to have this reduced by 10 mph is continuing.

A resident asked if the Parish Council could contact British Gas to revisit the possibility of the provision of mains gas to the Parish

CHAIRMAN

A resident complained about speeding and destruction of the grass verges along the Shurlock Road - this is an ongoing problem which is not helped by the lorries visiting the Downfield Pit. This will again be re-addressed with Highways team

A member of the public advised that a man hole cover in Shurlock Road which is made of inappropriate materials is too weak to take the traffic that goes across it - the Streetcare team will be contacted

A member of the public advised that the brick postbox near to Sill Bridge is falling over. Clive Scott-Hopkins advised that this has now been repaired

 A resident enquired whether a play area could be created at the cricket club in Shurlock Row. Katie Sarsfield advised she would be happy to make initial enquiries and Clive Scott-Hopkins will contact the trust that owns it

- Reduction in the height of Beech hedge in the Burial Ground
 these works will be completed tomorrow
- Open space along Shurlock Road the proposals for this area will be posted on the Parish Council's website, Facebook page & Twitter account and some will also be reproduced in the Lych Gate. The proposal is to develop a 13 acre bio diverse site between Pool Lane and Shurlock Road into a community open space with picnic benches, mown paths and parking. It is hoped that residents of the Parish will give feedback via an online survey. For residents with no internet access Katie Sarsfield will be able to arrange viewing of the papers. The Parish Council wish to received initial feedback/interest from parishioners before considering the opportunity further
- Maintenance tenders the Vice Chairman advised that 4 tenders had been sought and received. Following discussions it was unanimously agreed that ANB Groundcare would be awarded the contract again to December 2017

Discussions were held about setting the Precept figure for 2016/2017. The Councillors unanimously agreed that this would be raised to £17,500. The Parish Council recognised that the precept had been frozen at £14,000 for the last 7 years with very little capital expenditure having been incurred within the Parish during this time. As such the increase represents a step change to facilitate much needed capital investment (partly funded through reserves) and recognised the reduction in real terms of the precept in recent years. It was also recognised that the Band D cost in the Parish is still one of the lowest, if not the lowest in the Royal Borough. The Clerk will complete the necessary forms and send them into RBWM The Clerk presented an invoice to the Parish Council for approval that had been received from the RBWM for the Election expenses. This was approved and signed off by the Chairman
