Election of Officers for new Parish Council

John Birkett resigned as chairman of the Parish Council. He proposed Mike Kay to take over the position which was seconded by Clive Scott-Hopkins and unanimously agreed. He accepted the position. There were no other nominations for the role.

Mark Hipgrave proposed John Birkett to be Vice Chairman which was seconded by the newly elected Chairman and this was unanimously agreed. He accepted the position. There were no other nominations for the role

The other roles and responsibilities of the remaining council will not change

The Chairman on behalf of the Parish Council thanked John Birkett for his work during the past year

Public Question Time:

- A resident enquired about the Open Space proposal which could be located on the Shurlock Road. The Chairman advised that this was still being explored and that there were concerns. The RBWM own the land and would be interested in leasing the area to the Parish. A meeting is being scheduled for the Parish Council and RBWM to meet after which a public meeting will be held
- Strong concern was expressed about the huge lorries still travelling to and from the Downfield site on a daily basis. The local road network is suffering as the lorry drivers are not keeping to the route set out in the planning permission, they seem to be coming in from all directions. Soil is being stockpiled due to the newts on site and cannot be levelled. Two members of the Parish Council visited the site today to have a look around. The Clerk will write to Natural England to find out what the current situation is with the newts to see if work can be expedited. Cllr David Evans will speak to RBWM to see if he can do anything to assist

Matters Arising from the Minutes:

- Public Open Space as above in public question time
- Horse Margin on Twyford Road there is still some fence missing which is just as well as a recent accident saw a car go through the gap and into Blueys Farm field. Additional road markings are required on the bend before the margin, Suzy Young is continuing to pursue
- Network Rail The Parish Council are awaiting an update from the Enforcement Officer who in turn is awaiting an update from Network Rail. A resident of the Parish has recently had their car damaged by a low loader which had come over the bridge. A manager from Network Rail has offered to meet Suzy Young to discuss the best way forward
- Cricket Club play area proposal The Chairman has expressed a number of concerns one of which being the lack of a footpath along the Shurlock Road. Still ongoing
- Trees at Pond in Shurlock Row The Vice Chairman has contacted RBWM who have advised they will undertake any tree work that is required, in particular the Willow trees will need pollarding within the next 3 years
- Painting of phone box the box has been rubbed down and undercoated. It will be restored back to red later this week by some volunteers
- Notice boards now all repaired and keys given to Clerk
- Brook Lane Sue Fox at RBWM has confirmed that she is looking to fix the potholes which is hoped will help the drainage issues at the junction of School Road. The feasibility and cost of creating passing places along the lane will be carried out and we await the feedback. Suzy Young will keep a watching brief
- Parish letterhead to be carried forward
- Heavy tankers on Milley Road Agrivert tankers delivering to the lagoon at Church Farm and lorries delivering goods to the Network Rail site have been causing problems to the local residents. The Parish Council has been advised that the tankers are not carrying out anymore deliveries until November – which should help the situation

FC 4/05/2016 Travellers update:

Clive Scott-Hopkins reported on the Court of Appeal outcome. The Judgement refused the appellant's claim on all counts. The associated planning appeal matter remains outstanding and a decision to be distributed on or around 27th May. The Council were awarded their costs.
