## Public Question Time:

- David Crawley-Boevey advised he has noticed a lot of litter in verges and ditches especially along Shurlock Road between Crockfords Bridge and the Cricket Club. He asked that the Parish Council contact RBWM to establish if they have a workforce that clear litter. Borough Cllr. Maureen Hunt advised that she would assist in this matter.
- David Crawley-Boevey also complained about the detritus and leaves which are blocking the gulleys and requested that the RBWM were contacted to 'blast' the drains out

VICE CHAIRMAN

David Crawley-Boevey also asked where the bin outside the Neville Hall by the bus stop had disappeared to. Noone knew of its whereabouts. Vice Chairman advised that he would add this to the list of questions that need asking of the RBWM

VICE CHAIRMAN

Borough Councillor Maureen Hunt along with Freda Christodoulou brought to the Parish Council's attention the fact that there has been an increase in the activity of scramble bikes using the former waste pit site at Downfield. Access is being gained using the footpaths. Local concern has been expressed at the noise and the possible disturbance to the clay cap. The Clerk will write to Environmental Protection Officer and Rights of Way Officer
