Public Question Time:

A member of the public advised that it would appear that work to widen the access on the land east of Shurlock Road (Downfield Pit) had commenced on or about 27 May. This raised the following questions which the Clerk will address to the case officer Victoria Gibson:

- 1. Does the 9 month timescale in para 4.3 run from that date and what happens in inclement weather conditions arising out of the late start?
- 2. What steps are being taken to slow HGV traffic at the bend on Shurlock Road including SLOW signs and a solid white central line?
- 3. How do they intend monitoring the 20 in and out lorry movements per day to prevent excess usage of this narrow road without pavements?

- The Clerk advised that the RBWM had commissioned a refresh of the 2012 Gypsy & Traveller Accommodation Assessment through a series of field interviews with the gypsy and traveller community locally. This is a joint project with Wokingham & West Berkshire councils. The purpose of the new survey is to update the assessment of accommodation needs and this will inform a review of the need for pitches

• Jenny Baish advised that in spite of a recent speed survey being carried out and the results being sent to all three Borough Councillors no response had been received. She asked the Chairman if he could speak to them about this. Martin Hayes will pick this up with the RBWM Safety Officer in the absence of Jenny Baish over the next few weeks and to request that a risk assessment is carried out.

CHAIRMAN MARTIN HAYES

- The 'potential accident waiting to happen' at Milley Bridge due to the lack of fencing on the west side was discussed and it was agreed that a Network Rail Programme Office should be on side, David Gray a member of the public will give the Clerk the details of the person to contact
- The Chairman spoke of the SMART motorway proposals (widening using the two hard shoulders) and advised that a porous road surface and low lighting is installed along the Shurlock Row stretch of the M4 will be requested. He will write to the Highway Agency to request this
