Matters Arising from the Minutes:

- SID (Speed Indicator Display). Borough Councillor David Evans had advised that putting a permanent SID up in Shurlock Row was not the best way to go as drivers tend to ignore them after a while. It is preferred to move them around the villages so he is therefore investigating whether RBWM will purchase a SID for the use of the Parish. The weekly running costs (moving the SID around and replacing the battery on a weekly basis) is c£70 per week (c£3,640 per annum). Whilst he should be able to persuade RBWM to buy the kit they are unlikely to pay the weekly running costs. He had suggested to the Chairman that we should look into the possibility of sharing the SID with another Parish Council so the two Parish Councils could share the running costs. White Waltham have advised that they are not interested so we now await the response from Hurley
- It has now been agreed that Shurlock Row will be put on a list of schemes for a 20mph speed limit, given the presence of the nursery school. There are a number of such projects ahead of the village so we will have to wait our turn. We can however expect some entrance white painted gates
- Land east of Shurlock Road (Downfield Pit) The Chairman has been in touch with Victoria Gibson the planning officer who has

advised that this application is being recommended for approval – there have been no objections from Highways or the Environmental Agency (EA). This application will come in front of the Panel on 23 October. Borough Councillor Carwyn Cox will speak to the Environmental Officer to establish why the RBWM are so keen to approve the application. The new owner of Downfield east may allow the lorries through his access as an 'alternative route' but unknown as yet and the Borough have to agree
