A member of the public complained about the speed of traffic between Crockfords Bridge and the junction of Shurlock Road/Broadmoor Road and asked if the speed limit could be reduced to 30mph. The Chairman advised that unless there are several accidents on a particular stretch of road and a continuous built up area which would warrant the speed limit to be reduced there is very little that can be done. He also suggested that if the registration number of the speeding cars are noted and the local PCSO is advised they may be able to prosecute

- FC47/09/2013 <u>Matters arising from the Minutes</u>:
 - Speeding in Shurlock Row Penny Lovejoy representing the residents of The Street was in attendance advised that a consensus on what the residents require will be passed to Cllr David Evans to take back to the RBWM. Some speed checks have been carried out with the local PCSOs had given proof that speeding actually is happening but no one is sure what happens now. Cllr David Evans will be approached by the Chairman to see if he can help in the acquisition of a SID. It is noted that a serious accident happened a few months ago by the Royal Oak cross roads the correspondence relating to this incident will be copied onto Rt HonTheresa May and the police

obtain 3 quotes for the maintenance of the hedge and treeline at this boundary. It is noted that the owners of Lawrence House have erected a garden shed and the question of whether this structure has been built 1 meter away .from the boundary

FC48/09/2013 <u>Travellers update:</u> The Chairman gave an update and advised that the Oral Hearing will be heard later this year but the result is not expected before 2014.

FC49a/09/2013 <u>Planning Applications:</u> 12/02289: Oak Cottage, West End The Parish Council had no objection to this application subject to there being no conflict with GB4

> 12/02527: Annexe at Oak Cottage, West End The Parish Council objected to this application on grounds of material increase in size (GB2, GB3 & NPPF para 89) and on a potential flood risk

12/02280/81 (LBC) Barn at Bears Copse Farm, West End The Parish Council supported these applications

12/02333: Mathews Mead, West End The Parish Council had no objection to this application providing the annexe is subservient to the main house

13/01661: Downfield Pit (Land east of Shurlock Road) The Parish Council object to this application on the following grounds:

- 1. Inaccurate and inconsistent information provided on the traffic survey and duration, accident record, number of lorry movements every 10 minutes and why there is a deemed 82% reduction from the 2011 refused application when reducing the height from 2m to 1m is only 50%
- 2. The flood risk and thereby possible contamination of the water courses from site leakage
- 3. Particular concern is the volume of heavy lorries over a nine month period accessing a narrow road (2 lorries could not pass together) round a blind bend and adjacent to a listed building without foundations.

If the Borough are still minded to approve we would need to see the following conditions:

- 1 Highways we would wish to have a legal agreement on the precise route to be taken to the site, the size of the lorries and the nine month duration
- 2 Highways attention should be given to blind bend on the Shurlock Road and the need to prevent two lorry movements in two directions simultaneously
- 3 Satisfaction that there will be proper monitoring for possible contamination of materials to be brought onto

the site and assurances that it will be top soil and not subsoil. Also we query the quality of the capping material and where it comes from (unknown) 4 The restored land should be restricted to agricultural/equestrian and not for motorbike scrambling 5 Planning permission should be required for any event/competition use of the site likewise stabling/feed stores etc and PDR to be removed 6 What sanctions will be in place if any conditions are breached, damage to housing along the route and disturbance of roads in our Parish?
